I. INTRODUCTIONS

a. Dave White (DAW), Consultant Project Manager, welcomed everyone to the meeting and introduced members of the City, Program Management and Consultant Team. Refer to the attached sign in sheet for attendees.

II. OVERVIEW

- a. DAW was the key speaker and provided an overview of Key Contacts along with Project Information on the Background, Proposed Improvements, Current Site Condition and Project Elements. He noted that the current schedule is to release the 90% Plans and Specifications for informational purposes by June 20.
- b. DAW also presented the current Project Schedule and reviewed the requirements of the Prequalification Questionnaire in detail.
- c. DAW noted that it is important that any Project Reference, Company Resume or Staff Resume include an identification of the specific required technical experience in the write up. For example, Steve Jones oversaw a project with <u>10,000 VF</u> of auger cast foundation <u>piling</u> installation).
- d. The meeting agenda and presentation are attached to this meeting summary.

III. QUESTIONS

a. Several questions and answers were provided during either the meeting or the follow up visit. Questions (Q) and Answers (A) are provided below.

Q: Will the BIM model include quantities that will be available during bidding?

A: The BIM model will be provided upon request during bidding for informational purposes only, however quantity take offs should be taken from plans.

Q: Can the same projects provided in Part III also be used to demonstrate required experience in Part IV, or do they need to be different?

A: Project experience provided in Part III can also be used to demonstrate experience for the technical criteria identified in Part IV. Be sure to list the specific technical experience being satisfied by any Company or Staff Resume in the write up. Pre-Qualification Orientation Meeting Summary June 13, 2018 Page 2 or 2

Q: How do the escrow plans work?

A: The City has applied this provision on several large projects to assist with significant dispute resolution during construction. In general, supporting documentation related to bid preparation needs to be submitted and will be stored throughout the project in a safe deposit box paid for by the successful bidder (Contractor). This will only be accessed jointly by the City and Contractor if a significant dispute requires aid in resolution. Upon completion of the project, all items from escrow will be returned to the Contractor.

Further details are included in the 90% documents. The information is intended to not be made public and it was noted that this language is under City legal review to revise and further clarify in the final version of the specifications.

Q: Who is the Registered Managing Employee referred to on the PROJECT DATA SHEET located under Part III of the Project References?

A: This individual would be the Principal in Charge employed by the Contractor assigned with overall responsibility of the construction project. This individual does not have to be on site.

Q: For Part II Mandatory Requirements for Qualifications, on Pages 15 and 16, please clarify how many questions require a response.

A: There are a total of seven (7) questions on Mandatory Requirements that require a response – five on Page 15 and two on Page 16. On Page 16, replace in the first sentence "7." with "6." and on line eight, replace "8." with "7."

IV. SITE VISIT

a. After the presentation concluded, the site and grit building were made available for review by the attendees.
